- Jing Sun invited Vice President of Research Jack Hu and Consulate Ms. Qin JuHua to the stage and give their speeches

- Lan Deng called the meeting to resume at 8:00pm
- Jing Sun presented “Expression of Appreciation” on behalf of the ACP 2015 Executive Committee. “Thank you” plaque and gift were presented to Chuanwu Xi (ACP 2014 President), and Yiwei Deng (Dearborn campus long time representative who just stepped down).

 - Changed “4-8 Campus Representatives representing the following sites: the Central campus, the Medical campus,, the North campus, and the Dearborn-Flint campuses.” to “8 Campus Representatives representing the following sites: 2 representatives from each of the following three Ann Arbor campuses: the Central campus, the Medical campus, and the North campus; 1 representative from each of the following two campuses: the Dearborn campus and the Flint campus.”
